# **Membership Categories**

The ACOS membership is made up of individuals only; it has no corporate or institutional memberships. The College offers the following categories of membership:

### Full Membership

Physicians are eligible for Full Membership if they have graduated from an AOA accredited college of osteopathic medicine; have successfully completed a surgical residency training program accredited by the AOA or by the Accreditation Council for Graduate Medical Education (ACGME); and are fully licensed to practice medicine and surgery in the state in which they practice. Members are eligible for Dual Membership if they also are a member of the American College of Osteopathic Obstetricians and Gynecologists, the American Osteopathic Academy of Orthopedics, or the American Osteopathic Colleges of Ophthalmology and Otolaryngology–Head and Neck Surgery.

#### **Resident Membership**

Surgical residents who are enrolled in an AOA or ACGME accredited residency training program are eligible for ACOS resident membership.

#### Student Membership

Members of the national Student Osteopathic Surgical Association (SOSA) are student members of the ACOS.

#### Life Membership

Members who have reached the age of 60 and have maintained continuous membership in the ACOS for 20 years are eligible for life membership.

### **Retired Membership**

Members who have permanently retired from practice and do not qualify for life or inactive membership are eligible for retired membership status in the ACOS.

**Associate Membership** is available to any nonsurgical osteopathic and allopathic physician, or an advance practice provider currently employed by an ACOS member.
