### CANCELLATION OF EXHIBIT SPACE AND SPONSORSHIPS

Exhibitors and Sponsors (referred to as 'company' below) are requested to telephone and email the Vegas Cosmetic Surgery Show Management (Mindy Millat or Nydia Houck) with cancellations. However, the cancellation is not effective until it has been received in writing at the Vegas Cosmetic Surgery office, and acknowledged and approved by Show Management (Mindy Millat or Nydia Houck). No refunds will be granted after March 1, 2026. If the company cancels before March 1, 2026, 50% of the total cost of booth space or sponsorship will be retained by Vegas Cosmetic Surgery (If not paid yet, payment will still be due). If the company cancels on March 1, 2026 or later, Vegas Cosmetic Surgery will retain 100% of the total contract obligation (If not paid yet, payment will still be due). Any space not claimed and occupied, or for which special arrangements have not been made by 8:00 PM on Wednesday, May 27, 2026 will be forfeited and no refund issued and/or payment will still be due. ### CANCELLATION AND CHANGING THE DATE OF THE EVENT BY VEGAS COSMETIC SURGERY

**1.1.** Vegas Cosmetic Surgery reserves the right to cancel or change the date of the event at any time and for any reason (including, without limitation, if a force majeure event occurs which Vegas Cosmetic Surgery considers makes it impossible, inadvisable or impracticable for the event to be held).

For the avoidance of doubt, nothing in this clause shall excuse Company from the payment of the fees in accordance with the payment terms stated in the booking form.

**1.3.** Where the event is cancelled and is not reasonably expected by Vegas Cosmetic Surgery to be held in the following year the terms of this Clause 1.3 shall apply:

**1.3.1.** if the event is cancelled other than as a result of a force majeure event (in which case the provisions of Clause 1.3.2 apply), this Agreement shall terminate without liability provided that, at Company's election, any proportion of the fees already paid will be refunded or a credit note for the amount of the fees already paid will be issued and Company will be released from paying any further proportion of the fees;

**1.3.2.** if the event is cancelled as a result of a force majeure event, this Agreement shall terminate without liability provided that: (i) Vegas Cosmetic Surgery shall be entitled to retain an amount equal to 50% of the total fees (the Revised Fees) from any proportion of the fees already paid or, where no fees have been paid or where the proportion of the fees already paid is less than the Revised Fees, Vegas Cosmetic Surgery shall be entitled to submit an invoice in respect of the balance (or the whole as

the case may be) of the Revised Fees, which will become immediately due and payable; and (ii) after the deduction of the Revised Fees, at Company's election, any proportion of the fees already paid will be either refunded or a credit note issued for the amount of fees already paid and Company will be released from paying any further proportion of the fees.

**1.4** Company acknowledges that the provisions of this Clause set out Company's sole remedy in the event of cancellation or the changing of the date of the event and all other liability of Vegas Cosmetic Surgery is hereby expressly excluded.

Signage that is easily visible should be placed near the devices themselves and on any graphic depicting the device stating: "This device is not cleared by the FDA for distribution in the United States", or "This device is limited by Federal Law for investigational use only".
