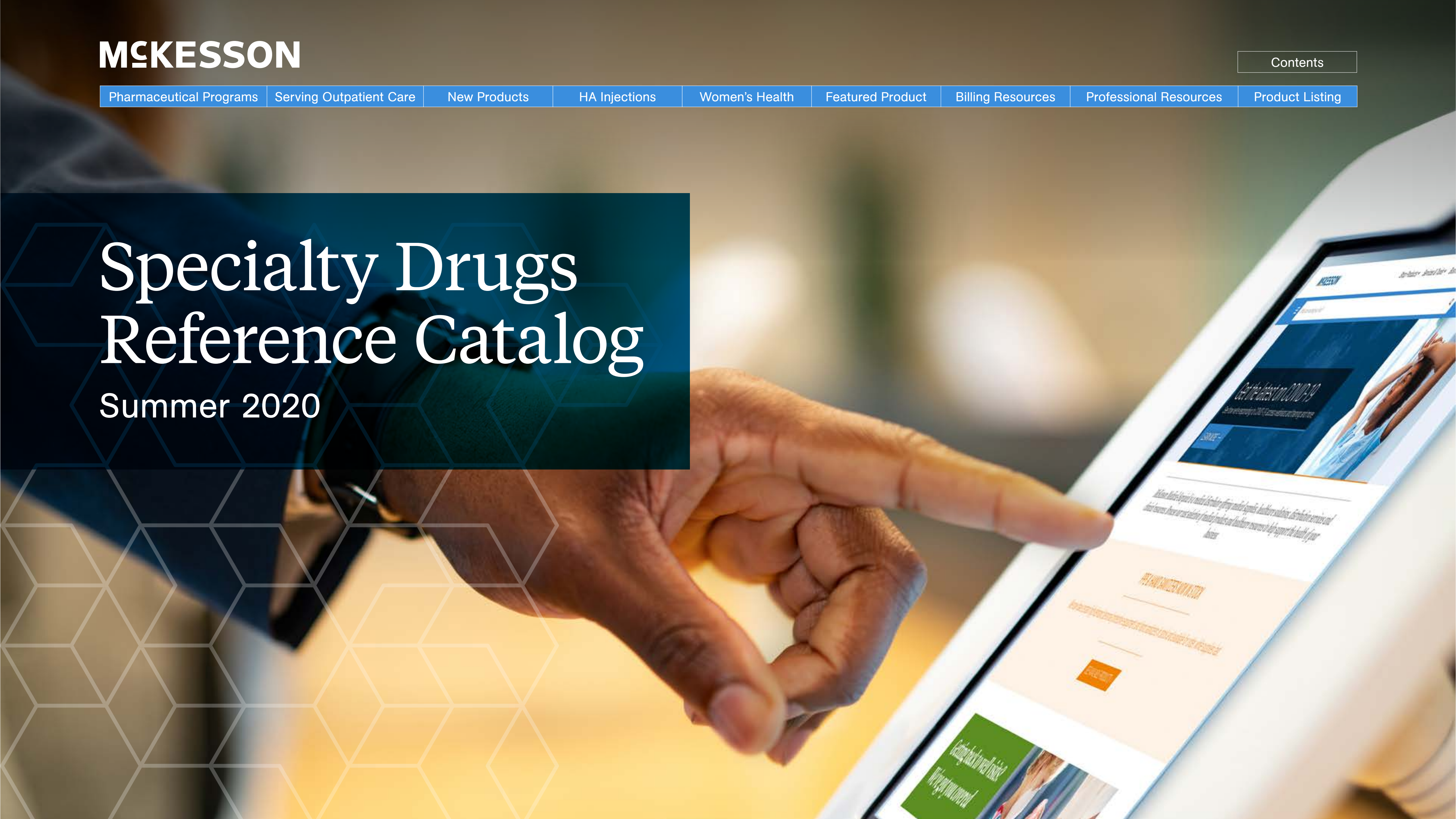

## Protecting and improving Medicare for our nation's seniors



Under Executive Order #13890, titled Protecting and Improving Medicare for Our Nation's Seniors (specifically under [Section 5](#)), the Centers for Medicare and Medicaid Services (CMS), plans to propose reform to the Medicare program that would significantly impact Physician Assistants (PAs) and Advanced Practicing Registered Nurses (APRNs).

On January 17, 2020, the American College of Cardiology provided a written response to CMS outlining specific examples of cardiologic services that APPs should be able to provide under general physician supervision. Read the [ASC Letter](#).

## Drug Supply Chain Security Act (DSCSA)

DSCSA is administered by the Food and Drug Administration (FDA) and has these objectives:

- Pharmaceutical drug integrity
- Traceability of drugs through supply chain
- A system of unique product identifiers
- Robust transaction history and information
- Efficient verification requests, responses to suspect/illegitimate products, effective recalls as needed
- National licensure standards for wholesale distributors and third-party logistics organizations

**Next Nov. 27, 2020, primary care providers and other dispensers may only accept products with valid Product Identifier.**
